<ul style="list-style-type: none"> <li>• <b>Do I need a signature and stamp endorsement from DBSI for submitting via MPN G2 eTax Payment?</b></li> </ul>	<ul style="list-style-type: none"> <li>• No need for physical endorsement, since all tax payments are processed electronically.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>Do I need to register before using IDEAL MPN G2 eTax Payment?</b></li> </ul>	<ul style="list-style-type: none"> <li>• Yes, you need to be registered on DBS IDEAL transaction service. After registration, the tax payment feature is available for you.</li> <li>• You may contact your relationship manager for assistance with the registration form.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>What types of taxes can be paid through IDEAL MPN G2 eTax Payment?</b></li> </ul>	<ul style="list-style-type: none"> <li>• You can pay your corporate import/export and excise taxes.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>Can IDEAL MPN G2 eTax Payment cater ID Billing creation for all tax payment type?</b></li> </ul>	<ul style="list-style-type: none"> <li>• As per regulation by tax authorities, creating ID Billing is only available for corporate tax.</li> </ul>

<ul style="list-style-type: none"> <li>• <b>What is the cut-off time for making tax payments?</b></li> </ul>	<ul style="list-style-type: none"> <li>• Cut-Off Time for MPN-G2 is at 03.00 PM through teller and 08.00 PM through DBS IDEAL Payments made after the cut-off time will be processed the next working day.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>How will I know my tax has been paid?</b></li> </ul>	<ul style="list-style-type: none"> <li>• The government tax office will issue you a tax receipt number (known as NTPN) to state that your tax has been paid. The tax receipt number will be embedded into tax receipt document (Bukti Penerimaan Negara – BPN) and will be distributed electronically.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>Is there a fee to use e-Tax Pay?</b></li> </ul>	<ul style="list-style-type: none"> <li>• There are no fees for processing tax payments through DBS</li> </ul>
